PUBLIC EVENTS TAKING PLACE FROM MONDAY 17 MARCH TO THURSDAY 20 MARCH 2025

The Tarchon interconnector project is proposed to create a direct power link between Essex in Great Britain, and a landing site at Niederlangen, in Lower Saxony, Germany. It will connect the two countries' energy markets, increasing the security and reliability of their electrical systems in addition to facilitating the integration of renewable energy sources.

The interconnector will be a combination of land and subsea cables approximately 750km in length and will allow 1.4GW of electricity to move in either direction.



ABOUT TARCHON

Tarchon is being developed by Copenhagen Infrastructure Partners (CIP), a global leader in renewable energy investments committed to making significant and meaningful contributions to the green transition, with support from a broad array of experts in their fields.

CIP manages 12 funds and has to date raised approximately EUR 31 billion for investments in energy and associated infrastructure from more than 180 international institutional investors.

Volta Partners has a minority ownership stake in Tarchon Energy Limited. The company was formed by senior financial advisors with expertise in power project development.

The Volta team has experience developing transmission lines and interconnectors, including the 1.4GW NeuConnect interconnector between Great Britain and Germany.

LOCATION

The Tarchon project will come onshore in the Tendring Peninsula, with a proposed landfall zone being considered south of Harwich. Underground cables will take the power from the landfall zone to connect with the proposed Tarchon converter station which will transfer the HVDC power to HVAC power which can be accepted into the grid. The Tarchon converter station will then connect to the proposed National Grid East Anglia Connection Node (EACN) substation, also via underground cabling.

During the consultation we will share information about our site selection processes and feasibility as well as plans for our 2025 activities. We will share more information about the types of environmental surveys that will take place and how we conduct them to ensure minimal disruption to the local area.
